



Also in February I was admitted to a hospital for stroke symptoms which turned out to be a brain seizure.

My mind has been distracted from my legal issues and I have developed a lack of contcentration similar to attention deficit disorder. If I am at the computer for any period of time I get lightheaded and must stop, thus delaying progress toward any appeal to your court.

I need time to complete my brief and to do a service of process on the Solicitor General.
