

**PETITIONER'S MOTION FOR AN EXTENSION OF
TIME TO FILE MOTION FOR LEAVE TO PROCEED IN
FORMA PAUPERIS AND PETITION FOR A WRIT
OF CERTIORARI**

NOW COMES the Petitioner, Tunzy A. Sanders, a Pro Se Litigant, and moves this Honorable Supreme Court to grant an extension of time in which to adequately prepare and file a Motion for Leave to Proceed in Forma Pauperis and Petition for Writ of Certiorari pursuant to Supreme Court Rule 30 (2) and in support of same states as follows:

1. That the Petitioner's habeas corpus claims were denied by the 4th Circuit Court of Appeals on March 1, 2019.
2. That on or about April 5, 2019, the Petitioner was placed in solitary confinement at the Allendale Correctional Facility pending the resolution of questionable claims of misconduct.
3. That the Petitioner has been a model prisoner for almost one hundred percent of the time that he has been incarcerated in the South Carolina prison system.
4. That the questionable charges were brought after the Petitioner expressed a desire to pursue his claims of harassment and intimidation by the Allendale Correctional prison guards.



5. That the Petitioner also asserts that the questionable charges were brought to obstruct his filing of civil claims in the U.S. District Court in Charleston and Columbia, South Carolina.

6. That the Petitioner further states that he believes the questionable charges were brought as retaliation for bringing his habeas corpus claims before the U.S. District Court.

7. That at almost the exact time that the Petitioner was about to file his civil claims in the U.S. District Court in Charleston, South Carolina, the questionable charges were lodged preventing Petitioner's preparation, signature and filing of not only this instant appeal to this Honorable Court, but also the filing of his civil claims in the U.S. District Court arising out of harassment and intimidation.

8. That on or about April 5, 2019, the Petitioner was placed in solitary confinement for approximately three weeks where the Petitioner was prevented from contact with family members that could assist him with the filing of this instant appeal.

9. That immediately after the Petitioner's confinement, a Allendale Correctional Facility prison guard visited the family home of the Petitioner and advising that the Petitioner was placed in solitary confinement and that "he could go free with time served if he pleaded guilty to the charges pending against him".

10. That the Petitioner continued to assert his innocence rather than plead guilty and after a hearing the Petitioner was sentenced to four months with no privileges, which included no communications nor phone calls to family.

11. That on or about April 26, 2019, the Petitioner was transferred to a new facility, Kershaw Correctional Facility, wherein he was once again locked down for twenty-three hours

and not able to access a law library or those that could assist with him with the preparation and filing of this instant appeal to the U.S. Supreme Court.

12. That even mail services to the Petitioner has been compromised as a result of the sudden and unexpected movement of the Petitioner from one facility to another.

13. That the Petitioner wishes to pursue an appeal to this Honorable Court and is requesting an additional 30 days to file his Motion for Leave to Proceed in Forma Pauperis and Petition for a Writ of Certiorari in this Honorable Court.

14. That the Petitioner asserts that he has demonstrated facts which constitute "extraordinary circumstances" which would qualify him for an extension of time to file the within stated motions.

15. That the Petitioner gave prior permission, via his signature, for his family to file this instant Motion for Extension of Time to File a Motion for Leave to Proceed in Forma Pauperis and Petition for a Writ of Certiorari.

WHEREFORE, the Petitioner respectfully requests that this Honorable Court grant his Motion to Extend Time to File Motion for Leave to Proceed in Forma Pauperis and Petition for a Writ of Certiorari.
