To the Honorable Sonia Sotomayor, Associate Justice of the Supreme Court of the United States and Circuit Justice for the Tenth Circuit:

Petitioner Ian Alexander Bowline prays for a 58-day extension of time, to and including August 7, 2019, in which to file his petition for writ of certiorari. In support of this request, counsel states as follows:

1. On March 11, 2019, the United States Court of Appeals for the Tenth Circuit affirmed the judgment of the district court in this case. A copy of that opinion is an attachment to this application.

2. Mr. Bowline has ninety days from March 11 to petition for a writ of certiorari. Sup. Ct. R. 13.3. Ninety days from March 11 is Sunday, June 9, making the petition due on Monday, June 10. Sup. Ct. R. 30.1. This application is being filed at least ten days before June 10.

3. The jurisdiction of this Court is invoked under 28 U.S.C. § 1254(1).

4. Over the last several weeks, I have filed the opening brief in United States v. Milhouse, No. 18-3245 (10th Cir.), and the petitions for writ of certiorari in Ejiofor v. United States, No. 18-9259 (U.S.) and United States v. Nanez-Rivera, No. 17-1419 (10th Cir.), and I have worked on a

district-court matter related to United States v. Means-Goodman, No. 18-8037 (10th Cir.). I therefore believe an extension of time will be needed adequately to prepare Mr. Bowline's petition for writ of certiorari.

5. The requested extension is for fifty-eight days, to and including August 7, 2019. During the requested extension period, I am responsible for filing the opening briefs in United States v. Young, No. 18-6221 (10th Cir.), United States v. Lovelace, No. 19-1100, and United States v. Oldman, No. 19-8023 (10th Cir.), and the reply brief in United States v. O'Neal, No. 18-1365 (10th Cir.). I also expect to be responsible for filing the opening brief in United States v. Trillo-Gonzalez, No. 19-2018 (10th Cir.), which is now due on June 5 and in which an extension will be sought.

WHEREFORE Ian Alexander Bowline respectfully requests that an order be entered extending his time in which to petition for certiorari by fifty-eight days, to and including August 7, 2019.
