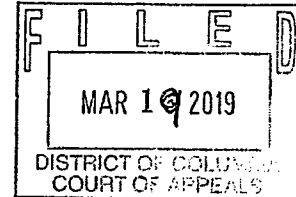

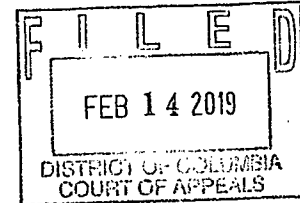

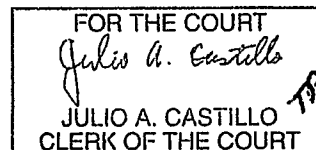
On further consideration of this court's January 29, 2019, order, it has been determined that this case is not appropriate for appellate mediation, it is

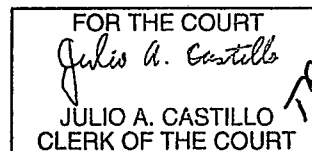
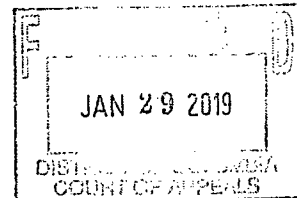

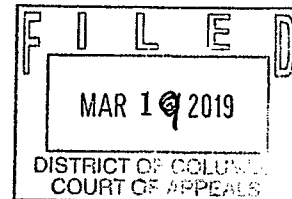
