
For the foregoing reasons, the district court's decision is **REVERSED**, and



Schwaller's actions, the fact that he did not have a bona fide work place violence procedure actively in place, started numerous false allegations and a hostile work environment, causing me to hire a lawyer, and thus getting fired illegally (three different documented times over a six month period when I wasn't even on the property.)
