**TO THE HONORABLE JUSTICES OF
THE SUPREME COURT OF THE UNITED STATES:**

Pursuant to *Supreme Court Rules, Rule 13.5 and 30.2*, I, the petitioner, *AMEER FLIPPIN*, pray for a *60-day extension* to file a Petition for a *Writ of CERTIORARI* in the *Supreme Court of the United States*.

Timeliness, Jurisdiction, and Opinion Below

On March 29th, 2019, the *District of Columbia Court of Appeals* issued an **ORDER of Dismissal** where a **Mandate** was issued on April 22nd, 2019, affirming a decision by the *Superior Court of the District of Columbia* where a complaint for abuse of discretion and a Violation of Civil Rights under *Title 42 of the United States Code, §§ 1983, Civil Action for Deprivation of Rights* was filed for the non-disclosure of the Write-In Candidacy for DC Mayor in 2018. The petitioner was excluded from the listing of candidates for DC Mayor in 2018 by the DC Board of Elections & Ethics.

The *Order of Dismissal* issued by the *District of Columbia Court of Appeals* is contained in *Appendix A*, and the *Mandate* of the *District of Columbia Court of Appeals* is located in *Appendix B*. Without taking into consideration the Clerk's "*Clerical Error*" on the docket where the Clerk refused to file documents over-the-

counter, a *Petition for Writ of Certiorari* would be due, pursuant to this Court's Rules 13.1, 13.3, and 30.1 on or before **June 29th, 2019**. This application is being filed more than ten days before that date. *See* Rule 30.2. The *jurisdiction* of this Court is to be invoked under ***28 U.S.C. § 1254(1)***.

Reasons for Granting the Extension

Procedural History

The applicant, Ameer Flippin, was denied access to the ***District of Columbia Court of Appeals Office of the Clerk*** where filings *over-the-counter* were refused. Several documents are *missing* from the docket which were filed in a timely manner. Therefore, the DC Court of Appeals and the Office of the Clerk have committed “*Clerical Error*” in this matter where ***Petitions for Writs of Mandamus*** are being prepared for filing both in the *DC Court of Appeals* and the *Supreme Court of the United States*.

Grounds for Certiorari Exist

In the undersigned petitioner's opinion, this case presents a Class Action Civil Rights issue worthy of presentation to this Court in a *Petition for Writ of Certiorari*. Whether the applicant's Civil Rights were deprived and whether a Write-In Candidacy should be disclosed to the general voting population are issues to be examined.

The Need for an Extension of Time

Without taking into consideration the “*Clerical Error*” committed by the Office of the Clerk where filings at the counter were denied by the DC Court of Appeals, The petition is currently due June 29th, 2019, based on the existing docket where filings are excluded.


In addition, I, *Ameer Flippin*, require more time to complete the research and writing that is required to support a fully-developed *Writ of Certiorari*. A large case load and the service of process requirements have created urgent deadlines for timely filings. An additional *60 days* past the current deadline of June 29th, 2019, is required as my existing legal workload is heavy. A *Petition for Writ of Mandamus* in the DC Court of Appeals, a *Petition for Writ of Certiorari* in the Supreme Court, and a *Petition for Writ of Mandamus* in the Supreme Court are being prepared for filing.

WHEREFORE, I, *Ameer Flippin*, Applicant-Petitioner, requests that an ORDER be entered extending by 60 days the time within which to Petition this Court for *Certiorari*.
