

MOTION FOR EXTENSION OF TIME TO FILE FOR PETITION FOR
WRIT OF CERTIORARI

Herenow comes, Defendant/Appellant, John S. Benchick, Pro Se, requests an extension of time to file brief for petition for Writ of Certiorari, of final order, dated 4/27/2018 of the United States Court of Appeals for the Sixth Circuit, and hereby states the following:

1. Defendant/Appellant, John S. Benchick, Pro Se is currently incarcerated at Pensacola Federal Prison Camp.
2. Defendant/Appellant is indigent and had been appointed a public defender, for his Direct Appeal in the U.S. Court of Appeals for the Sixth Circuit, and attaches his docket sheet, that shows approval of IFP on 3/20/2018.
3. Defendant/Appellant requests an extension of 60 days.
4. Defendant/Appellant attaches lower court opinion, and also attaches order denying rehearing.
5. Defendant/Appellant's Direct Appeal Case No. : 16-2471 was final 4/27/2018, yet a related case No. : 17-2336 was docketed 11/06/2017 and is still pending, hence the request for an extension, in lieu of Case No. : 17-2336 concerning the outcome of an inaccurate copy of Defendant/Appellant's Trial in District Court, has greatly affected the Direct Appeal in Case No. : 16-2471.
6. Defendant/Appellant has been in contact with two individual attorneys who are considering taking this case, Pro Bono. however, as of this date, neither has yet to agree to the representation, thus compelling Defendant/Appellant to now file Pro Se, necessitating the instant extension request in order to file his petition for Writ of Certiorari.

Wherefore, Defendant/Appellant requests that this Honorable Court, grant the Defendant/Appellant, John S. Benchick, Pro Se an extension of 60 days time, in which to properly file for a Writ of Certiorari.


