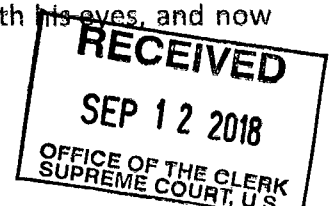

COMES NOW Syed Askri, ("Askri" or "Petitioner") files his Corrected
motion/request/petition to this Honorable Court to grant 40 days extension to file the
