PETITIONER'S APPLICATION FOR EXTENSION OF
TIME TO FILE PETITION FOR WRIT OF CERTIORARI
TO THE FIRST CIRCUIT.

To the Hon. Stephen Breyer, as Circuit Justice for the First
Circuit:

Petitioner Carlos Cruz-Rivera, through appellate counsel
appointed under the Criminal Justice Act, 18 U.S.C. §
3006A(d)(6), Ines McGillion, Esq., respectfully moves the Court
pursuant to Supreme Court Rules 22 and 13(5) for an extension of
60 days, from December 13, 2018 to February 11, 2019, to file his
petition for a writ of certiorari to review the First Circuit's
September 14, 2018 judgment and opinion (enclosed). The

defendant did not file a petition for rehearing. The Court's jurisdiction is based on 28 U.S.C. § 1257.

1. The date on which a petition for writ of certiorari would otherwise be due, if not extended, is December 13, 2018. Petitioner is filing this application well in advance, and thus more than the minimum ten days before that date. See S. Ct. Rule 13(5).
2. The undersigned has additional briefing responsibilities in Massachusetts state courts and in the Second Circuit during the relevant time period.
3. The undersigned is unable to work during one week in November, limiting the time that would otherwise be available to prepare a petition.
4. In addition, the undersigned is a solo practitioner with no employees and the requested time is reasonably necessary to enable preparation of a petition.
