MOTION FOR EXTENSION OF TIME TO FILE
PETITION FOR A WRIT OF CERTIORARI

Pursuant to Supreme Court Rule 13.5, the Petitioner Kacey Lewis, Pro Se hereby moves with a motion for an extension of time of sixty(60) days, up until October 24, 2018 to file his writ of certiorari.

JURISDICTION

The jurisdiction of this court is invoked under 28 U.S.C. Section 1254(1).

JUDGMENT SOUGHT TO BE REVIEWED

The Petitioner seeks for review a judgment entered by the United States Court of Appeals for the Second Circuit on June 5, 2018, wherein the Court of Appeals Affirmed the District Court's judgment granting Respondents summary judgment motion. See Lewis v. Lee, NO. 17-3432(CA 2NY, SUMMARY ORDER Appended hereto).

REASONS THAT JUSTIFY EXTENDING TIME

The Petitioner Kacey Lewis is an inmate confined in a state prison in Connecticut, and is proceeding without the assistance of counsel. The State of Connecticut does not provide inmates in their correctional institutions with access to law libraries or other

materials to conduct legal research. Instead, the State of Conn. contracts with the Law Offices of Bansley & Anthony for the Inmate Legal Aid Program (I.L.A.P.). As such, the Petitioner must submit requests to I.L.A.P. to obtain the legal information necessary to draft and file his petition for writ of certiorari, and he estimates his requests and petition will be completed by the time requested, i.e., on or before October 24, 2018.

Additionally, extending the time is necessary because the Petitioner has other pro se cases before State and Federal Courts: Kacey Lewis v. Warden, State Prison, NO. TSR-CV154006877(Conn.Super. Ct)(Where the Petitioner's habeas corpus-post conviction trial recently commenced, and the Petitioner is representing himself); Kacey Lewis v. Dr. Mark Frayne, et al, NO. 18-1668(CA 2NY)(Where the Petitioner is representing himself on appeal, and his appellate brief is due on September 7, 2018). WHEREFORE, the Petitioner urges the Court to grant this motion.

LEGAL BASIS

Petitioner relies upon this Court's Rule 13.5, which permits the Court to extend the time to file a petition for a writ of certiorari for a good cause.
