Application to Extend the Time to File
a Petition for a Writ of Certiorari

Comes now, Adam Alan Anderson, pro se, and respectfully moves this Court pursuant to Supreme Court Rules 13.5, 30.2 and 30.3 to grant an extension of time to file a petition for a Writ of Certiorari to review the denial on August 7, 2018 of Anderson's criminal appeal by the Eighth Circuit Court of Appeals, Case number 17-2223. Anderson asked his attorney to file this writ and he has refused. Anderson has made diligent efforts to complete the drafting of his petition by the current due date which Anderson believes is on or about November 7, 2018, Anderson is unable to complete the Writ by the expected due date. Anderson has not made any prior request for an extension of time.

Anderson offers the following in support of this request:

I. Jurisdiction.

The jurisdiction of this Court is invoked under 28 U.S.C. SEC 1254 (1). The decision and opinion of the Court of Appeals was entered on April 25, 2018.

II. Decision sought to be reviewed.

The decision and opinion of the Eighth Circuit Court of Appeals was issued on August 7, 2018, under case no. 17-2223. To Anderson's knowledge, this opinion is not published. A copy of the opinion is included herein.

The District Court and Eighth Circuit have previously allowed Anderson to proceed in forma pauperis.

III. Conclusion.

Anderson respectfully requests that the Justice of the Supreme Court that has supervisory responsibility over the Eighth Circuit, please grant this continuance.


