During the immediate time period following the denial of the petition for rehearing. The Petitioner was transferred to a medical facility for personal medical reasons and has not been able to prepare the petition for writ of certiorari within the allotted time period. The Petitioner has very recently return to a facility in which access to law library and personal legal property and case file can be granted to prepare the writ of certiorari.
