Application to Extend Time to File Petition for Writ of Certiorari:


Comes now, John T Williams pro se Litigant to file for an extension of time to file a Writ of Certiorari with the Supreme Court. This court has jurisdiction based on the second circuits opinion on September 5, 2018 under 28 U.S.C.1254(1). Mr. Williams has included copies document 334 and document 335 of the orders denying his petition for panel rehearing pursuant Rule 40 with the suggestion of a rehearing en banc pursuant Rule 35(b).

The reason Mr. Williams ask this court give him the full 60-day extension is because he is a pro se his writ of certiorari. The petitioner has been confined to the Dismiss halfway house in Atlanta since his release from prison on September 27, 2018. The defendant is not allowed to be released to home confinement or go to the law library until the (U.S.P.O) United States Probation Office approves his paperwork. This simply delays the defendant from doing his work.

The U.S.P.O has made it very difficult for Mr. Williams to fight his case, it seems that the probation office is deliberately delaying the paperwork, in order to keep Mr. Williams confined to the halfway house. The defendants home residence has already been approved back in March or April of this year. Further, there are people who have their paperwork done the same day or week, most of these people are white, this is very disturbing. The Northern District of the U.S.P.O should be thoroughly investigated for blatant government misconduct. For these reasons Mr. Williams ask this court for an additional 60-days to file his Writ of Certiorari.
