After a hearing was held on JL Dumas LLC's Motion To Vacate Foreclosure Judgment
on November 4, 2016, and this Court being otherwise fully advised in the premises, the Court
finds that the Motion should be denied and summary disposition should be granted in favor of
the Wayne County Treasurer;

NOW, THEREFORE;

IT IS HEREBY ORDERED that JL Dumas LLC's Motion To Vacate Foreclosure Judgment with respect to the property identified as Parcel Identification No. 16014894-901, commonly known as 8711 Epworth, Detroit, MI (the Property"), shall be and hereby is denied with prejudice for the reasons stated on the record during the hearing;

IT IS FURTHER ORDERED that summary disposition shall be and hereby is granted in favor of the Wayne County Treasurer pursuant to MCR 2.116(C)(4) and (C)(10).

IT IS FINALLY ORDERED that the Stipulated Order entered by this Court on October 24, 2016 which provides for the staying of the issuance of the deed to the Property to the auction sale purchaser shall be and hereby is set aside.

This Order does not dispose of the last claim and does not close this case.
