





TO THE OFFICE OF THE CLERK, SUPREME COURT OF THE UNITED STATES:

NOW COMES, the petitioner, Gary Lee Jackson, Pro Se, in the above captioned matter, move this Honorable Court for an extension of time within which to file Writ of Certiorari and, in support thereof states the following:

1. The petitioner's Writ of Certiorari is currently due on November 18, 2018.

2. The petitioner, however, must ask for an extension of sixty (60) days to adequately review, research, properly prepare and file Writ of Certiorari in this matter.

3. The petitioner received the SUR PETITION FOR REHEARING from the UNITED STATES COURT OF APPEALS FOR THE THIRD CIRCUIT (DENYING) the petitioner's; Petition for Request for Rehearing by the Panel and the Court En Banc, on August 20, 2018

4 Due to the limited amount of time remaining of six (6) days, it is impossible for the petitioner to meet the deadline.

5. Due to a recent transfer from one facility to another, various property issues, limited access to the Law Library, and the petitioner's Pro Se status of never having file anything of this nature and magnitude. It is inconceivable that the petitioner can meet the current deadline.

6. The petitioner is currently on the waiting list to attend the Law Library to gain the necessary access to information needed to properly file the Writ of Certiorari in accordance with the Rules and Procedures of this Honorable Court.




