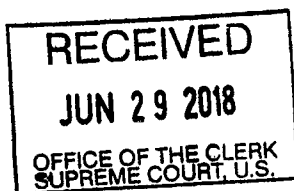

lawyer over a petitioner.

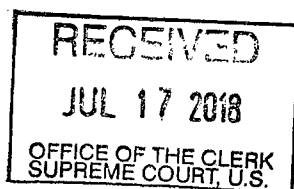
