BACKGROUND

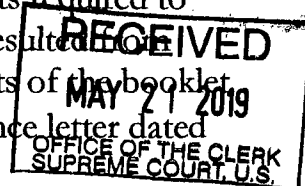


REASONS

- 3) Mr. Eric Streeter, Pro Se' appellee, submitted his petition for a writ of certiorari 10 days pass the due date in order to be able to have enough expendable income to cover the printing charge for the increase in booklet pages and quantity of booklets required to send to the Court and the Defendants. The increase in booklet pages resulted from significant corrections Mr. Streeter had to make in the appendix contents of the booklet to meet requirements outlined by the Clerk of the Court's correspondence letter dated



February 22, 2019. Upon getting a completed print order of booklets, Mr. Streeter immediately sent, via FEDEX overnight delivery, the required booklets to the Court and the Defendants on May 03, 2019 before the Court notified Mr. Streeter that his submitted petition for a writ of certiorari was out of time via correspondence letter dated May 07, 2019. Mr. Streeter acted in good faith to meet Court requirements, and he did not have an indication before his submitted petition that the length of the delay had any impact on judicial proceedings. It is Mr. Streeter's prayer that the Court grants his motion to file out of time his petition for a writ of certiorari.
