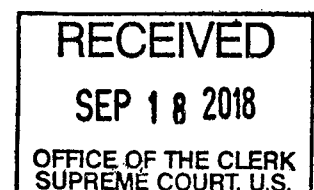
MOTION FOR OUT-OF-TIME FILING

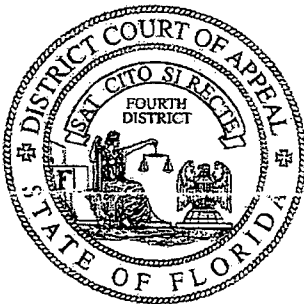

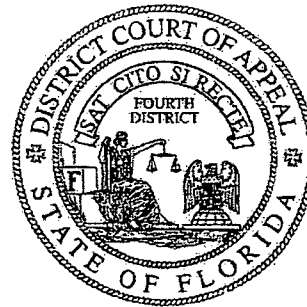
