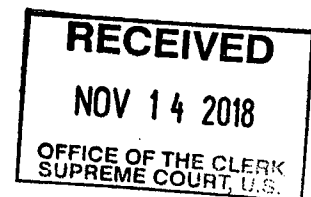
MOTION TO FILE OUT OF TIME APPEAL/CERTIFICATE

TO THE CLERK AND THE JUSTICES of the United States Supreme Court, movant, Terry L. James moves the clerk and Justices of the United States Supreme Court to allow hi m to file his Forma Pauperis and Writ of Certtiorari into this Honorable Court.

Movant recently filed his Writ of Certiorari into the U.S. Supreme Court in which it was returned as Out of Time.

Movant avers his Writ of Certiorari is not out of time, and that he should be allow to file into this Honorable Supreme Court for the following reasons:

Movant, Terry L. James initially filed this suit against El Dorado Casino in the 26th Judicial District Court of Louisiana (See: attached Appendix A of movant's enclosed Writ of Certiorari).



Movant, thereafter properly file appeal in the 2nd Circuit Court of Appeals of Louisiana.,

Movant was thereafter awarded an oral argument hearing in the 2nd Circuit Court of Appeals. (See 2nd Circuit oral arguments hearing record.)

However, after said hearing movant's appeal was subsequently denied. (See Attached Appendix C of Movant's enclosed Writ of Certiorari).

Thereafter, movant properly filed Writ of Review to the Louisiana Supreme Court in November of 2017.

After movant's petition had been in the Supreme Court over six (6) months in July of 2018 movant Decided to call the Louisiana Supreme Court to check the status of his writ.

Over a telephone conversation with the clerk movant was informed by the clerk that his writ was denied by in February and that he didn't understand why the denial had not been mailed out to him, but that he would go ahead and send it off to movant right away.

Movant thus come received the ruling July 27, 2018. (See Appendix E of movant's Certiorari mail receipt post mark date).

Movant prays that since he didn't find out his petition had been deny until he called into the Louisiana Supreme Court July 2018, and where he didn't receive this notice until July 27, 2018 movant should be granted the opportunity to file his Writ of Certiorari into the Honorable United States Supreme Court as proper where he did actually beat the ninety (90) day dead-line from July 27, 2018.



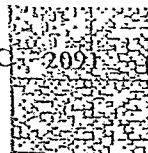
