

Motion To the Clerk

Gustave S. Drivas prose, respectfully requests that this is a Motion to the Clerk of the Court to file my petition of Writ of Certiorari out of time.

Reasons for Granting Request

Drivas is currently incarcerated and proceeding ProSe. On July 6, 2018 Drivas was transformed from Loretto FCI, to Canan Prison and was housed in the SHU(Secured Housing Unit) with no access to phones or computers, while waiting to be transferred to his present institution Schuylkill-Camp. On July 16, 2018 Drivas was transferred to Schuylkill Camp. Drivas was without his personal property including his legal material for approximately two weeks until he received it. During the month of August 2018 the prison was locked down for approximately three weeks. During this time Drivas had limited access to the legal library and typing equipment. During this time the hours of operation for the library + typing room was reduced to three hours a day. Drivas had to compete with other 225 inmates for access to three legal computers and three typewriters at all other times during three hours of operations during the week. In addition Drivas' hours are also limited due to institution recalls for Census Count, Fog Count and his work assignment during



the week, which all eventually interfere with his access to legal material and research.

Conclusion

For the reasons stated above Drivas respectfully, requests to the Clerk of the Court to grant this motion for extension of time and accepts his Writ of Certiorari which is enclosed.


