Dear Mr. Harris:

The State of Maryland, by and through undersigned counsel, pursuant to U.S. Sup. Ct. R. 30.4, respectfully requests an extension of time within which to file the brief in opposition to petition for writ of certiorari in the above-captioned case through and including June 12, 2020.

Raminder Kaur's petition for writ of certiorari was docketed in this Court on January 15, 2020, and the State waived its right to respond on February 25, 2020. On March 12, 2020 this Court requested a response from the State to be filed by April 13, 2020. On March 12, 2020, the State requested an extension of time to and including May 13, 2020, which was granted on March 13, 2020.

A second extension of this deadline is necessary based on assigned counsel's current workload. Between the date this Court requested a response and the current deadline for that response, assigned counsel is filing six briefs in Maryland's intermediate appellate court. Additionally, counsel's ability to prepare and file a response by May 13, 2020, has been hampered by constraints incurred as a result of the COVID-19 emergency. For these reasons, undersigned counsel respectfully requests a second 30-day extension of time in
