Pursuant to Supreme Court Rule 30.4, the State of Tennessee respectfully requests an extension of 28 days, to and including April 24, 2020, within which to file its response to the petition for a writ of certiorari in *Hamm v. Tennessee*, No. 19-1059. The petition was filed on February 19, 2020. The State's response is currently due on March 27, 2020. Petitioner does not oppose this request.

This is the State of Tennessee's first request for an extension of time. The extension is needed because the State's counsel of record, Sarah K. Campbell, has significant oral argument and briefing obligations near the current deadline, including an oral argument in *Holland v. State of Tennessee*, No. W2018-01517-SC-R11-PC (Tenn.) (scheduled for April 1, 2020), and a petition for certiorari in *Thomas v. Bright*, No. __-__ (U.S.) (due April 3, 2020, after a 60-day extension). Moreover, counsel was not involved in the
