Dear Mr. Harris:

I write to request an extension of time for respondent Thomas Grossman, Jr., MD to respond to the petition for certiorari filed in this case. Dr. Grossman's brief in opposition to certiorari is presently due on April 17, 2020. I request a 60 day extension of time through and including Wednesday, June 17, 2020 to file this response.

The reason for this request is two-fold. I am currently working on an appellate brief due to the Wisconsin Court of Appeals on April 27, 2020 in *Barsuli v. Virtual Radiologic Corp. et. al.*, Appeal No. 2020AP0289.

Secondly, pursuant to the Court's March 19, 2020 order regarding COVID-19, I am requesting an extension of time on those grounds. With Wisconsin stay-at-home restrictions in place, my staff is working remotely which is resulting in longer than usual time delays in the preparation of briefs and other written submissions. Deliveries to our office are impacted and coordination with outside vendors assisting our firm has been limited.

I will endeavor to submit my response prior to June 17; however, in this time of uncertainty, I feel that a 60 day request is best considered under the circumstances.
