**PETITION FOR REHEARING**

Pursuant to Rule 44 of this Court, the Petitioner, Arthur O. Armstrong hereby and respectfully petitions this Court for rehearing on grounds limited to intervening circumstances of a substantial or controlling effect or to other substantial grounds not previously presented. This petition presents these relevant questions for this Court's attention:

- 1 Whether respondent Sheriff of Wilson County, Calvin L. Woodard, Jr., on February 12, 2019, violated petitioner's Fourth and Fourteenth Amendments rights when respondent trespassed on private property of petitioner, made an entry, without a warrant, on personal premise of petitioner, dragged the petitioner from his bed, searched and seized his property and invaded his privacy, dragged the petitioner onto the road, handcuffed /arrested the petitioner, put petitioner in the cruiser and hauled him down to the magistrate's office without due process of law.

2 Whether Respondent magistrate's office, on February 12, 2019, acted with active connivance in the making of the failed to appear false reports and other conduct amounting to official discrimination clearly sufficient to constitute denial of right protected by the Equal Protection Clause to deprive petitioner of liberty and property without due process of law when respondent arrested petitioner when respondent placed petitioner under a \$13,000.00 cash bond in violation of the Fourth and Fourteenth Amendments to the Constitution of the United States.

3. Whether respondent Keith Stone, on February 13, 2019, in Wilson County, NC, without probable cause, arrested petitioner from Wilson County detention center when he handcuffed petitioner, searched and seized his property and invaded his privacy, put petitioner in his cruiser and hauled him to the Nash County jailhouse and jailed him for 120 days without due process of law in violation of the Fourth and Fourteenth Amendments to the Constitution of the United States.

4. Whether respondent Quentin T. Sumner acted with active connivance in the making of the DWLR false reports and other conduct amounting to official discrimination clearly sufficient to constitute denial of rights protected by the Equal Protection Clause to deprive petitioner of liberty and property without due process of law in violation of the Fourth and Fourteenth Amendments to the Constitution of the United States..

5 Whether respondents, in a conspiracy, failed to conform to the requirements of the federal constitution and laws of the United States to deprive the petitioner of liberty and property without due process of law when they jailed petitioner for 120 days without due process of law in violation of the Fourth and Fourteenth Amendments to the Constitution of the United States.

6. Whether, without probable cause, respondents deprived petitioner of liberty and property without due process of law in violation of the Fourth and Fourteenth Amendments to the Constitution of the United States

#### CONCLUSION

Petitioner's petition for rehearing should be granted.
