AFFIDAVIT
IN SUPPORT OF MOTION FOR LEAVE TO PROCEED AS A VETERAN

I, SSG EDWARD STARLING, am the appellant-petitioner in the attached-entitled case. In support of my motion to proceed as a veteran from the payment of fees or court costs, may proceed without prepayment of fees or costs or furnish security therefor and may file a motion for leave to proceed on papers prepared as required by Rule 33.2 upon Rule 40.

My setting out the moving party's veteran status is that I was first required to Register with the Local Draft Board upon graduation from High School; and was summoned to The Fort Benning Army Post-Fort, Columbus, Georgia in 1950 for assignment to The 97th Inf Div, but was given relief for immediate medical problems of my Mother who needed my care and support.

In 1952, I voluntarily enlisted into the United States Air Force and underwent Basic Training at Lackland Air Force Base, San Antonio, Texas.

As an Airman-Third-Class, I attended Technical School at Frances Air Base, Cheyenne, Wyoming, for Accounting and Airways-And-Air Communications; and following completions; I was assigned to The 803rd Supply Squadron, Stregit Air Command; but; after six (6) months after being there; the Fort Benning Army Commander was granted his request to send me back to Post-Fort Benning as a SCARWAF (Special Catagory Army With Airforce).

I did Active Duty in The States and Foreign Countries in Europe, Puson Korea, and Vietnam War Zones and was exposed to the Chemical Agent Orange and Other Gasses, and thereafter, was given An Honorable Discharge for Medical Reasons.

Official copies of my TDRL Orders and thereafter, my Permanant Retirement Orders are attached hereto; and I am now a Totally Disabled American Veteran with a One-hundred Percent (100%) Rated Disabled American Veteran.

I declare pursuant to the Penalty of Perjury that the foregoing and within is True and Correct pursuant to Title 28, U.S.C.A., Section 1746.

Dear Sir/Madam:

This is in response to your Certification-verification Requests to the above-named subject.

The Order convening the Formal Hearing was called to Order at 1044 hours, 29 Jan 68.

Voting Members of the Board present were: Jack S. Jenkins, Col., President; Herbert T. Clough, Jr., Col.(MC) Medical Member; Joseph A. Schiefen, Jr., Major, Personnel Member; and Myself, Word L. Gidden, Lt.Col., USAF, JAG, to represent the Rights of SSgt Edward Starling before the Board.

The Personnel Member then submitted into evidence papers pertaining to the Case marked as exhibits "A" through "F", as applicable, in accordance with AFM 35-4, for service-connection disabilities sustained by SSgt Edward Starling in line of duty for: Lower Back, Hip and Spinal Nerve Center Columns in 1953, at Wiesbaden Air Base, Germany (supported by Official Accident Report done by Lt. Col.J.P. Ryan, Materials Officer, and USAF Dispensary-Hospital Medical Treatment Records).

Residual Head Trauma sustained by falling 50 Cal. USAF F-86-D Metal Gunnary Rack (supported by Official Accident Report from Major C. E. Yeager, Commander, 50th Ftr.Bmr. Wing, Hahn Air Base, Germany in 1954).

Both of these sustained service connected disabilities occurred in line of duty during peace time but while SSgt Edward Starling was entitled to receive active duty pay. They can be seen at exhibits "A" and "B", attached.

The disabilities for Diabetes Mellitus, type II; Tinnitus; Heart Disease(s); and Leg Wounds (from metal fragments exposures while on Med Evac Duties), were all sustained by SSgt Edward Starling while in the Republic of Vietnam in 1966, while he was deployed by Special Order Amendment Return to Active Duty for six (6) months TDY Status pursuant to Title 10, US Code, Thomas A. Goodman, Wilford Hall USAF Hospital, San Antonio, Texas, who controlled all activities of SSgt Edward Starling from 1964 through 1968.

All of these Four (4) described injuries sustained by SSgt Edward Starling in 1966 were supported by the Official Records from the Charlie Field Hospital, Doctor O.B. Long, MC, Bien Hoa Air Base, Vietnam, while dispensing Toxic Agent Orange and Other Deadly Herbicides by both from the air and on the ground, at ongoing Combat Targeted Cites activities.

These Four (4) service connected disabilities sustained by SSgt Edward Starling occurred while in line of duty and were as a direct result of armed conflict or caused by an instrumentality of war and incurred in line of duty during period of was.

Because no objections were made by any of the voting members of the board, the united Decision was accepted as both Certification and Verification of All Claims, "A" through "F" as service connected disabilities submitted by Personnel Officer Joseph A. Schiefen, Jr., Major, on behalf of SSgt Edward Starling's Claims.

Disability Ratings were, therefore, established at Ten-Percent (10%), initially, for each of the Six (6) Disability Claims for service connected active duty activities, in addition to SSgt Starling's theretofore Mental Disability service connected Claim.

The Records for these Four (4) Claims can be viewed at exhibits "C" through "F".
