The opinions in this case issued on July 22, 2019. Petitioners filed a petition for rehearing en banc on August 5, 2019, urging that the panel's opinion conflicted with an earlier opinion issued in Sec. & Exch. Comm'n v. Stanford Int'l Bank, Ltd., 927 F.3d 830 (5th Cir. 2019). The panel granted that petition to clarify its view that there was no conflict and circulated that opinion to the full court. Holds on the mandate were lifted, and the clarifying opinion and revised dissent were filed on December 19, 2019, with the direction that the mandate issue forthwith, see Docket No. 240; FED. R. APP. P. 41(a), thereby commencing the time for Petitioners to file a petition for a writ of certiorari, 90 days from December 19, 2019. 16AA FED. PRAC. & PROC. JURIS. § 3986 (4th ed. 2019) ("[T]he court can grant rehearing only while it still has jurisdiction of the case and its jurisdiction ends when the mandate issues.") (citing Boston & Me. Corp. v. Town of Hampton, 7 F.3d 281, 282 (1st Cir. 1993); Johnson v. Bechtel Assocs. Profl Corp., D.C., 801 F.2d 412, 415 (D.C. Cir. 1986)). The motion for extension of time is denied. Further motions for extension of time shall be addressed to the Supreme Court of the United States.
