Accordingly, we respectfully request a thirty (30) day extension of time until August 31, 2020, to file a brief in opposition to the Petition for a Writ of Certiorari.

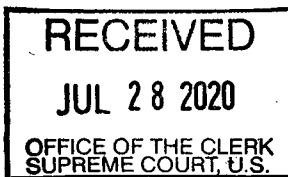
