
Petitioner's deadline to file her petition was extended 150 days because of the ongoing public health concerns relation to COVID-19.

Based on the national emergency associated with COVID-19 and the corresponding work restrictions and social distancing guidelines, the Respondent needs additional time to prepare its response. The current restrictive conditions make it difficult for counsel to confer with their client and complete the response in the time normally allotted under the Supreme Court Rules.

In addition, the undersigned counsel for the Town (Hudson C. Gill, Esq.) was out of the office for personal reasons from July 1 through July 12 and was unable work on the response during this time.
