

# Exhibit D

As support for the hourly rates requested with this motion: we have attached a list of cases where the timekeepers listed have received our new rates or have received **increased rates** in black lung claims(see #1-65); and we have, also, attached a list of **older cases** where the timekeepers listed have received our previous rates in black lung claims(see #66-88). Additionally, we have included on this list the time duration for these cases. A review of the list clearly shows Attorney Wolfe has received fee awards of \$300 per hour for more than ten years. In fact, the Benefits Review Board approved a fee award of \$400 per hour for Mr. Wolfe's work during February 2005 thru January 2007. Furthermore, he has received \$300 per hour for time as early as 1998.
