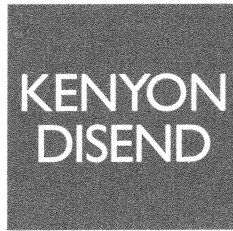



We thank you for your time and attention to the foregoing.


