(The patient was then awakened and moved to the recovery room in satisfactory condition). It was also signed by the Dentist. Date typed Feb 7, 1989. Page 3. Request for Administration of Anesthesia And For Performance Of Operations And Other Procedures. My husband signed this document. My husband James L. Toole got all of his teeth pulled and also his free dentures from the Biloxi VA Hospital. Page 4. All of this copy did not come out. But it has most of my husband's name Toole, James L. on it. And one digit of his social security number is missing 424-42-7647. Only veterans that is

classified as one hundred percent disabled can get dental work done by the VA. I am filing a copy of the Origin of the VA Motto Lincoln's Second Inaugural Address. Thanks to President Abraham Lincoln for promoting one of the best known sentences in the English language. All men are created equal. That sentence is on the United States Declaration of Independence. I am filing a copy of President Abraham Lincoln's Gettysburg Address. The Gettysburg Address, then the Gettysburg National Cemetery was dedicated by President Abraham Lincoln. A brief four months after the battle. Lincoln's speech lasted only two minutes, but it went into history as the immortal Gettysburg Address. (Immortal - exempt from death, destined to be remembered forever). "Four score and seven years ago, our fathers brought forth on this continent a new nation: conceived in liberty, and dedicated to the proposition that all men are created equal. 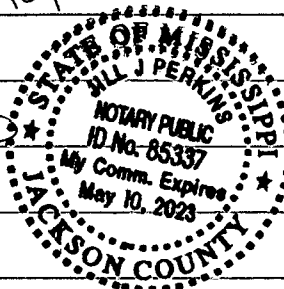

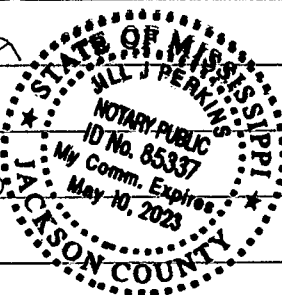
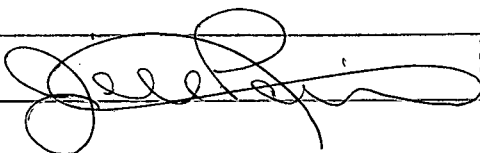
