Christopher M. Murray, Chief Judge, acting under MCR 7.203(F)(1), orders:

The motion to waive fees is GRANTED and fees are WAIVED for this case only.

The delayed application for leave to appeal from the January 31, 2018 order is DISMISSED because appellant failed to file the application within the time period required by MCR 7.205(G)(3). The application was not filed within six months of the January 31, 2018 order, and the six-month period is not counted from the entry of the order deciding appellant's motion for reconsideration because the motion was not filed within the initial 21-day appeal period. MCR 7.205(G)(3)(b). Furthermore, the exceptions found in MCR 7.205(G)(4) are inapplicable.


