



STATEMENT OF THE CASE

On both cases, original filing 5:16-cv-70, FL # 18-2219, my documents were "NOT" entered on time and or deleted all together. The Courts and their employees had committed OBSTRUCTION OF JUSTICE. I had to contact the FBI, citing CIVIL RIGHTS VIOLATIONS as I am a Pro Se Litigant and my CIVIL RIGHTS were violated. I sent in all of my documents and all 16 Defendants were served by the US Marshal's. None of the 16 Defendants RESPONDED. It was only after I mailed in the DEFAULT JUDGEMENT that Attorney Roberto Rameriz became counsel. Attorney Rameriz represented all 16 Defendants. He knew this was a "CONFLICT OF INTEREST" and in the Appeals Court only represented OPM. Both courts have failed me, and for this reason, I am requesting that I am granted the WRITS OF CERTIORARI for my case to be heard before the judges. The judges should be DISMISSED to what these lower courts are doing to Pro Se litigants.

REASONS FOR GRANTING THE PETITION

The Attorney, Attorney Roberto F. Rameriz represented All 16 Defendants in his capacity as the Assistant United States Attorney, knowing that this was a "CONFLICT of INTEREST" and did so without the knowledge of All 16 Defendants.

I ask that my petition be granted based on OBSTRUCTION of the Courts, their employees and Attorney Rameriz.

The Courts failed to process my documents in the ORDER of timely manner that they were received. Changing documents dates to begin the lawsuit process. This is "FRAUD" on the Plaintiff, CIVIL RIGHTS violations on the Plaintiff.

I ask that my petition be granted based on CIVIL RIGHTS VIOLATIONS, FRAUD, and the manipulation of my documents and in PACER.gov.

The Courts allowed a Deputy Clerk to electronically sign the Judgment 5:16-cv-70-FK, Sandra K. Collins, for dismissing my case knowing that a "PRACTICE" had been filed against Judge Louise W. Flanagan and court employees. I ask that my petition be granted.

CONCLUSION

The petition for a writ of certiorari should be granted.
