**AFFIDAVIT OR DECLARATION
IN SUPPORT OF MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***

I, Donna Sneller, am the petitioner in the above-entitled case. In support of my motion to proceed *in forma pauperis*, I state that because of my poverty I am unable to pay the costs of this case or to give security therefor; and I believe I am entitled to redress.

In Forma Pauperis Affidavit

This Affidavit and Declaration to proceed in forma pauperis is respectively issued by My article III one supreme Court in the nature of a Common-law Peremptory Writ of Mandamus necessary in aid of the two Supreme Courts respective Jurisdictions, to the inferior Supreme Court of the United States and the Clerk and Honorable Justices thereof as a Supreme Court established and persons holding office under the authority of the United States of America within the territorial limits and independent sources of Jurisdiction of the Country of the said United States; and, under protest for the following reasons.

It abridges my substantive rights and the exceptional circumstances of this extraordinary particular Case arises under the supremacy of the construction of the Constitution, the Laws and a pre-constitutional Treaty of the United States involving the fall of the barrier to review, the political question and public rights Doctrines of popular National corporate government, the rise of Claims of sovereign Immunity and the Supremacy of the Rules of Law of the Land of the appropriate alternative Government of the Country of the said United States beyond the particular Facts of popular State and Federal corporate governments of the Nation.

Even though there may be a prejudice Conflict of Interest in the Supremacy of the Rules of Law of the Land of the proper alternative Government of the Country of the said United States, the Clerk and the Honorable Justices of the federal Supreme Court of the United States cannot Rightfully and Lawfully refuse to hear a controversy that the construction of the Constitution, the Laws, a Treaty of the United States and the Court's own statutes and case law has created, even though the resolution of the controversy between the two Supreme Courts, found within the phrase "The Supreme Court and all courts established by Act of Congress" in 28 U.S.C. 1651(a) and 28 U.S.C. 2071(a), may have national political implications.

The inferior Supreme Court of the United States of America is asking the superior Article III one supreme Court of the Land of the Country of the said United States to seek leave to proceed in forma pauperis, and the right and power to deny the in forma pauperis cannot be maintained by the de facto sovereignty and standing of the Nation, the United States of America doing a usufructuary business within the territorial Limits of the Country of the said United States. There still remains a body of private Common law to be applied upon all commercial transactions and contracts made within the territorial limits and independent sources of Jurisdiction both as to Law and Fact of the

pre-constitutional and constitutional relinquished claims, by the United States of America in the 1783 Definitive Treaty of Peace and the Last part of Article IV section 3 clause 2 of its adopted 1787 Constitution of the United States as "Claims of the [said] United States", to the predominating appropriate territorial Government of the Country of the said United States.

The Supreme Court of the United States [of America] through its own in former pauperis statute, by asking Donna Sneller to apply for leave has in itself, departed from the Constitution of the United States at Article I section 8 clause 9, Article III section 1, and Article VI clauses 1, 2 and 3, and is abridging my substantive rights.

In these exceptional circumstances of this Article III Case and Controversy the appropriate ultimate Law-making power in this Country, truly known as the said United States and not the United States of America has determined the governing Law, and all the judicial powers are required to follow and give unquestionable adherence to the appropriate ultimate Law-making powers, both as to law and Fact, "within the United States".

The United States of America has already pre-constitutionally relinquished all claims to the government, propriety, the territorial rights of the same and every part thereof to the Country of the said United States in the 1783 Definitive Treaty of Peace.

There is a reversed creditor debtor relationship in these exceptional circumstances; therefore the so-called in forma pauperis is respectively ordered **not to be denied**.

This Affidavit and Declaration is respectively made by My Article III one supreme Court under the federal statute 28 U.S.C. 1746(2), within the United States.
