

"I, SAMEER P. SETHI, having direct knowledge of the below facts in this affidavit, do declare and bare witness as follows:


On June 30, 2019, I have filed with the Supreme Court of the United States, by depositing with the courier service FEDEX, for delivery within three days (i.e. delivery to the address of the U.S. Supreme Court by July 3, 2019), a petition for writ of certiorari to the Supreme Court of the United States. Such petition for writ of certiorari was filed by me, Defendant Sameer P. Sethi, and was with regards to the case Sethi Petroleum LLC and Sameer P. Sethi vs. Securities and Exchange Commission (which such case was originally tried in the Northern District of Texas, then appealed to the 5<sup>th</sup> Circuit Court of Appeals, and now being sought for review by the U.S. Supreme Court through the aforementioned petition for writ of certiorari). This aforementioned June 30<sup>th</sup>, 2019 filing of my writ of certiorari is a resubmission pursuant to a May 1, 2019 notice from the Supreme Court, stating that due to formatting issues, a corrected write of certiorari must be filed within 60 days of the notice.

Copies of the aforementioned June 30<sup>th</sup>, 2019 filing have (in addition to the one original and 10 copies sent to the Supreme Court) also been sent to each the Securities

Exchange Commission, the US Dept. of Justice/U.S. Solicitor General, and the Receiver in the case.

I further affirm that the above-mentioned June 30<sup>th</sup>, 2019 filing (resubmission) was, like the original submission, in-fact, a petition for writ of certiori to the Supreme Court (and intended by me to be such).
