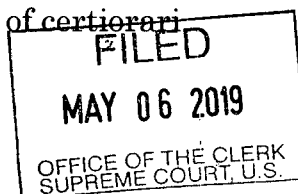


The petitioner asks leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.

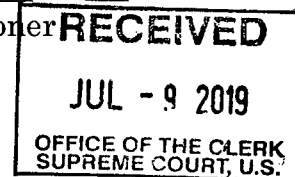

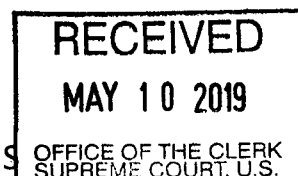

**AFFIDAVIT IN SUPPORT OF MOTION FOR LEAVE TO PROCEED

This petition for certiorari and its motion and affidavit to proceed *in forma pauperis*, are but an end result of litigation involving myself and a previous wife (the marriage being annulled in 2015). Litigation, consisting of the multitude of actions she brought against me over the last four years, and which literally has consumed my life. Each of those actions being purportedly premised upon an alleged loan.

As a result of judgments which were rendered in those actions, I've been left literally, with nothing but the clothes on my back. I've not only lost all real estate I owned prior to that marriage (including inherited family land), but have also suffered the loss of any and all personal property I once possessed. Much of that personal property represented both a lifetime's worth of work and achievement (not only mine, but my father's), as well as, my only sources of future economic well-being. The personal property/possessions I have lost, include but are not limited to: important business and personal documents, every shoe, article of clothing, jackets, housewares, books, other misc. heirloom items, my bed and bedding, even the food in my cupboards. In addition was heavy machinery, equipment, tools, building materials, trailers, and multiple motor vehicles; vehicles which included even the truck and trailer I used daily, and which, for being self-employed, were imperative to my even being able to earn a living.

In summation, my inability to pay for the costs of this case is a result of the injustice I've suffered and which is the reason I am seeking the aid of this most respected Court. Injustice which, as of June 12, 2018, left me literally out on the street, with nothing more than the shoes and clothes I had on.
