**APPLICATION FOR A 60-DAY EXTENSION OF TIME TO FILE A PETITION  
FOR A WRIT OF CERTIORARI FROM THE JUDGMENT OF THE  
UNITED STATES COURT OF APPEALS FOR THE ELEVENTH CIRCUIT**

Petitioner, Henry Vazquez Valois, respectfully requests a 60-day extension of time, to and including July 12, 2019, within which to file a petition for a writ of certiorari from the decision of the United States Court of Appeals for the Eleventh Circuit. Mr. Vazquez Valois has not previously sought an extension of time from this Court.

The jurisdiction of this Court will be invoked under 28 U.S.C. § 1254(1).

Mr. Vazquez Valois appealed the judgment and sentence imposed in the district court which was affirmed by the Eleventh Circuit Court of Appeals, Eleventh Circuit Case No. 17-13535-F. The Eleventh Circuit affirmed his judgment on February 12, 2019. A copy of the Court of Appeals' decision affirming the judgment is attached as Exhibit A. Unless extended, the time within which Mr. Vazquez Valois must file a Petition for a Writ of Certiorari will expire on May 13, 2019. *See* S.Ct. R. 13.5.

Undersigned counsel has the following other matters: Emergency jurisdictional question letter brief and an initial brief in Case No. 19-10606, *United States v. Nevia Abraham*; and initial briefs in Case No. 19-10163, *United States v. Surmondrea McGregor* and in Case No. 18-15339-A, *United States v. Etevaldo de Souza*. The undersigned is also working on a Petition for a Writ of Certiorari in *United States v. Jason Rosado*.

Undersigned counsel believes that additional time will be important for the effective representation of Mr. Vazquez Valois. No party will be prejudiced by the granting of a 30-day extension.

Accordingly, Petitioner respectfully requests that an order be entered extending the time to file a Petition for Writ of Certiorari by sixty days, to and including July 12, 2019.
