

Grounds;

On July 23, 2018 Steven A. Williams notified the United States Court of Appeals for the Seventh Circuit ref: Case NO: 18-291, that he was requesting an extension (docs enclosed) regarding his time limit to gather and provide supporting documentation to the court. He was experiencing paralysis in his legs; vision loss, and other severe medical ailments and conditions that precluded him from being able to meet the specified timeline of the court.

This is the Certificate stating that the grounds are Limited to Intervening Circumstances of Substantial:

On November 13-20, 2018, Steven A. Williams, was admitted to Memorial Medical Center in Springfield, Illinois (docs enclosed) due to persistent paralysis in his legs and several medical complications.

On December 1-9, 2018 Steven A. Williams was additionally admitted for medical care to St. John's Hospital in Springfield, Illinois (docs enclosed) due to on-going paralysis in his legs and additional severe medical complications.

Steven A. Williams had other extraordinary and extenuating circumstances that prevented him from meeting the United States Court of Appeals for the Seventh Circuit Court directed timelines. He was severely injured during an accident that occurred when he was directed to step onto an AMTRAK lift. The lift malfunctioned (collapsed), while he was standing on it August 23, 2016.

Steven A. Williams has been on prescribed narcotics and muscle relaxers due to the constant debilitating pain he has suffered from since the injuries that he incurred on February 5, 2012. Mr. Williams's doctors say that he will be relegated to a motorized wheel chair for the rest of his life.



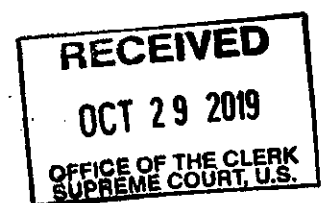
