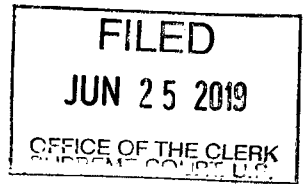

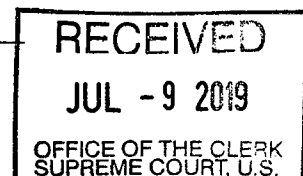

So I can get the medical care I need and that defendant have a legal duty to provide.

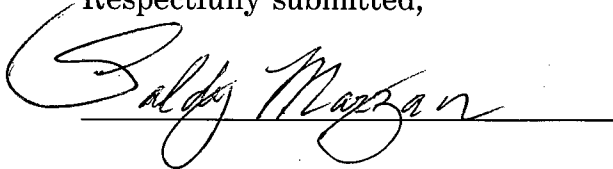
This is the only way to rescue me free from this tribulation prison criminal activity.
