Dear Mr. Harris:

Pursuant to United States Supreme Court Rule 30(4), the State of Arizona respectfully requests a second, 11-day extension of time to file the Brief in Opposition to Petitioner's Petition for Writ of Certiorari in this case. The Brief in Opposition is currently due on October 21, 2019. The State of Arizona requests an extension of time to and including November 1, 2019. Hedlund's counsel, Sara Chimene-Weiss, does not oppose this request.

The parties agree that a case before this Court involving Hedlund's co-defendant, *McKinney v. Arizona*, No. 18-1109, presents the same issues and should be dispositive of Hedlund's pending petition. (See Petition for Writ of Certiorari, at 2-3, 31-32; Motion to Extend, filed 8/13/19.) *McKinney* will be argued on December 11, and Arizona is preparing to file its merits brief on or before October 25. Given that undersigned counsel has been recently occupied with the merits brief in *McKinney*, and the likelihood that Hedlund's petition will be held pending the outcome of *McKinney*, Arizona asks for the instant short extension in *Hedlund*.
