COMES NOW, Garry Randall West, the Pro Se Petitioner in this proceeding, respectfully Petitions for a Rehearing, pursuant to the Rules of the Supreme Court of the United States (2019), of the Order of the Court entered on October 7, 2019, denying the Petition For Writ Of Certiorari. (See, Exhibit A, attached)

This Petition is made on the following grounds:

- 1) The Court IGNORED its own recent Supreme Court Rulings, which clearly support Petitioner's claims supported in *Carpenter v. U.S.*, 138 S. Ct. 2206 (2018), *Riley v. California*, 134 S. Ct. 2473 (2018), *Collins v. Virginia*, 138 S. Ct. 1663 (2018), cases which the Supreme Court REVERSED and REMANDED.

2) Cases recently REVERSED and REMANDED by the Supreme Court clearly show that Police MUST produce a warrant to search in the absence of Exigent Circumstances, as clearly testified in the Record by Police in Petitioner's Trial Court; Petitioner is due equal protection by the United States Supreme Court.

See, *Carpenter v. U.S.*, 138 S. Ct. 2206 (2018), *Riley v. California*, 134 S. Ct. 2473 (2018), *Collins v. Virginia*, 138 S. Ct. 1663 (2018), Support cases which the Supreme Court REVERSED and REMANDED.

3) The warrant for Petitioner's residence was invalid! Some type of warrant served at Petitioner's residence was not in Petitioner's name. (See, Original Record pages 34-35). The State of Oklahoma conceded at Petitioner's Post-Conviction Hearing by admitting on the Record – three (3) years after conviction – that the search warrant for Petitioner's residence could not be explained and had no connection whatsoever in [his] case. At that hearing, the State immediately submitted some type of *corrected warrant* to the Record without permitting presentation to / or objection from the defense, which is an Oklahoma Court Rule 4(e) violation, depriving Petitioner his right to object to new evidence presented to the Court.

4) Police cannot seize or search for data or information, even digital data, without a valid warrant! Data, information, and material, no matter

what it regards, are private, sensitive, confidential, and are extremely privileged.





