Access this link - Use Internet Explorer 8 or newer (or Safari 5 for Macs) DO NOT USE Firefox.

1. The default appellate username is your **FirstNameLastName** (Case sensitive and no space, e.g., JohnSmith). You will receive a separate email with your default password. The system security will automatically lock after three failed login attempts. If this happens, you will need to contact the Clerk's Office.

2. Click on **My Profile**: In the **Login Info** section, click **EDIT**:

a) You have the option to change/reset your username. Click on the **CHANGE** button to edit your username, if desired.

b) You must reset your password. To change the password, click **RESET**, type the new password in both fields and click **RESET** again. Any revised password must be at least 8 characters long and contain at least one UPPERCASE letter, one lowercase letter, one number, and one special character (e.g., <validated? Not>

4. Review and correct the information in the **Attorney Info** section. You must add your personal social security number and confirm it before you can continue. Press **SAVE**.

5. In the **Billing Info** section: Select the Self-Employed button if you wish your Form 1099 to go to your social security number or the Firm button if you wish the Form 1099 to be reported to your firm EIN (and enter your firm EIN). Fill in the information requested. Press **SAVE**. The billing information is used for tax reporting purposes and will not be maintained by the court. You are responsible for keeping this information up to date.

6. Log out and then log back in.

7. You should now have access to your home page.

The combination of the username and password within the CJA eVoucher Program will serve as your signature for filing the voucher or documents under the Federal Rules of Civil, Criminal, and Appellate Procedure, CJA Guidelines, the Local Rules, and any administrative orders and policies of the Eighth Circuit Court of Appeals.
