To the Clerk of the Court:

We represent Respondents, Estate of Kevin Brown, by and through its successor-in-interest Rebecca Brown, and Rebecca Brown, in her own right, in the above referenced case. Petitioner Michael Lambert filed his Petition for Writ of Certiorari on October 21, 2019 and the matter was placed on the docket on October 25, 2019. Respondents' brief in opposition to the Petition for Writ of Certiorari is due on or before November 25, 2019. Pursuant to Rule 30.4 of the United States Supreme Court, we request a thirty (30) day extension of time to file a brief in opposition to the Petition for Writ of Certiorari. Because a thirty-day extension of time would mean Respondents' opposition to the Petition for Writ of Certiorari would be due on December 25, 2019, a federal legal holiday under 5 U.S.C. § 6103, as set forth in Rule 30.1, Respondents respectfully request a due date of December 26, 2019.

I am counsel of record in this case and am anticipated to begin trial in California Superior Court on November 18, 2019 that is scheduled to take at least one week. My colleagues and co-counsel, Ms. Julia Yoo and Ms. Grace Jun, are responding to multiple post-trial motions in another case that are due to be filed within the first two weeks of November.

For these reasons, we respectfully request a thirty (30) day extension of time, until December 26, 2019 under Rule 30.1, to file a brief in opposition to the Petition for Writ of Certiorari. On today's date, Ms. Richardson, counsel for Petitioner Michael Lambert, was informed of Respondents' request for a thirty-day extension of time to file an opposition to the Petition for Writ of Certiorari. Ms. Richardson stated that she had no objection to a thirty-day extension.
