

ORDER

AND NOW, this 21st day of July, 2017, upon consideration of the motion (Doc. 325) of defendant Mark A. Ciavarella, Jr. (“Ciavarella”), for appointment of counsel with respect to his pending motion (Doc. 322) to vacate, set aside, or correct sentence pursuant to 28 U.S.C. § 2255, and the court concluding that an evidentiary hearing is required, see R.
