IMPRISONMENT

The defendant is hereby committed to the custody of the United States Bureau of Prisons to be imprisoned for a total term of: One hundred fifty (150) months on Counts 1 & 2; Sixty (60) months on Count 3; One hundred twenty (120) months on Count 6. The term imposed on Counts 1, 2 & 6 shall be served concurrently. The term of imprisonment imposed on Count 3 shall be served consecutively to the terms imposed on Counts 1, 2, & 6. That pursuant to Public Law 108-405, revised DNA Collection requirements under the Justice for All Act of 2004, the defendant shall submit to DNA collection while incarcerated in the Bureau of Prisons, or at the direction of the U.S. Probation Office.

X The court makes the following recommendations to the Bureau of Prisons:
1) That the defendant be housed in a facility where he is given the opportunity to obtain his GED.
2) That the defendant, throughout the duration of incarceration, shall enroll in some form of educational program, such as vocational, technical, or college preparatory.

X The defendant is remanded to the custody of the United States Marshal, pending his designation.

SUPERVISED RELEASE

Upon release from imprisonment, the defendant shall be on supervised release for a term of:
Five (5) years on Counts 1 and 2. Three (3) years on Counts 3 and 6. The supervised release terms shall be served concurrently.

X The defendant must report to the probation office in the district to which the defendant is released within 72 hours of release from the custody of the Bureau of Prisons.

The defendant shall not commit another federal, state or local crime.

The defendant shall not unlawfully possess a controlled substance. The defendant shall refrain from any unlawful use of a controlled substance. The defendant shall submit to one drug test within 15 days of release from imprisonment and at least two periodic drug tests thereafter, as determined by the court.

- ☐ The above drug testing condition is suspended, based on the court's determination that the defendant poses a low risk of future substance abuse. (Check, if applicable.)
- X The defendant shall not possess a firearm, ammunition, destructive device, or any other dangerous weapon. (Check, if applicable.)

STANDARD CONDITIONS OF SUPERVISION

- 1) the defendant shall not leave the judicial district without the permission of the court or probation officer;
- 2) the defendant shall report to the probation officer in a manner and frequency directed by the court or probation officer;
- 3) the defendant shall answer truthfully all inquiries by the probation officer and follow the instructions of the probation officer;
- 4) the defendant shall support his or her dependents and meet other family responsibilities;
- 5) the defendant shall work regularly at a lawful occupation, unless excused by the probation officer for schooling, training, or other acceptable reasons;
- 6) the defendant shall notify the probation officer at least ten days prior to any change in residence or employment;
- 7) the defendant shall refrain from excessive use of alcohol and shall not purchase, possess, use, distribute, or administer any controlled substance or any paraphernalia related to any controlled substances, except as prescribed by a physician;
- 8) the defendant shall not frequent places where controlled substances are illegally sold, used, distributed, or administered;
- 9) the defendant shall not associate with any persons engaged in criminal activity and shall not associate with any person convicted of a felony, unless granted permission to do so by the probation officer;
- 10) the defendant shall permit a probation officer to visit him or her at any time at home or elsewhere and shall permit confiscation of any contraband observed in plain view of the probation officer;
- 11) the defendant shall notify the probation officer within seventy-two hours of being arrested or questioned by a law enforcement officer;
- 12) the defendant shall not enter into any agreement to act as an informer or a special agent of a law enforcement agency without the permission of the court; and
- 13) as directed by the probation officer, the defendant shall notify third parties of risks that may be occasioned by the defendant's criminal record or personal history or characteristics and shall permit the probation officer to make such notifications and to confirm the defendant's compliance with such notification requirement.

SPECIAL CONDITIONS OF SUPERVISION

The Court finds that this offense is drug related. As such, the periodic drug testing mandated by the Violent Crime Control and Law Enforcement Act of 1994 is hereby enacted.

The defendant shall submit to one urinalysis within 15 days of release on supervision and at least two periodic tests thereafter.

It is ordered that, if deported, the defendant shall not attempt to enter, or re-enter the United States, without the advanced written permission of the Attorney General of the United States or the Secretary of Homeland Security.

Additionally, the defendant shall continue to be enrolled in some form of educational program throughout the duration of supervised release, such as technical, vocational, or college preparatory.
