





The defendant came before the Court for sentencing and appeared, in the custody of the Sheriff of this City, represented by appointed counsel, **Sara Gaborik**. The Commonwealth was represented by **Michael Hollomon**. Ernestine Thorne-Akers, Probation Officer, was present in Court.

On December 2, 2010, the defendant was found guilty of the following offense:

The presentence report was considered and is ordered filed as a part of the record in accordance with the provisions of Code § 19.2-299.

Pursuant to the provisions of Code § 19.2-298.01, the Court has considered and reviewed the applicable discretionary sentencing guidelines and the guidelines worksheets. The sentencing guidelines worksheets and the written explanation of any departure from the guidelines are ordered filed as a part of the record.

Before pronouncing the sentence, the Court inquired if the defendant desired to make a statement and if the defendant desired to advance any reason why judgment should not be pronounced.

The Court **SENTENCES** the defendant to:

Incarceration with the **Virginia Department of Corrections** for the term of: **40 years**.

The Court **SUSPENDS 10 years** of the sentence for a period of life, upon the following conditions:

**Good Behavior.** The defendant shall be of good behavior for life upon the defendant's release from confinement.

**Supervised Probation.** The defendant is placed on probation to commence upon release from incarceration, under the supervision of a Probation Officer until released by the Court or by the Probation Officer. The defendant shall comply with all the rules and requirements set by the Probation Officer. Probation shall include substance abuse counseling and/or testing to be monitored or approved by the Probation Officer.


