MOTION AND APPLICATION FOR IN FORMA PAUPERIS

Petitioner Tong Lor, acting pro se is respectfully requesting to move this Honorable Court to grant the Motion for In Forma Pauperis. The following facts are in support of the motion:

1. Petitioner family hired Attorney Mr. Dana B. Carron (P44436) to provide legal representation and file a petition for habeas corpus in the United States District Court Eastern District of Michigan Southern Division. On October 5, 2018, the District Court Judge Avern Cohn, issued an order denying the petition for writ of habeas corpus and denying certificate of appealability. Case no. 2:16-11028, Tong Lor v. Shane Jackson

2. Petitioner unable to continue paying for retained counsel, filed his own pro se an Application to Proceed in Forma Pauperis of appeal, pursuant to Fed.R. App. P.24(a)(1), to file his certificate of appealability in the Sixth Circuit Court of Appeals. District Court Judge Cohn granted the Petitioner's request to proceed in forma pauperis on appeal, on December 27, 2018.

3. Petitioner filed a certificate of appealability in the Sixth Circuit Court of Appeals, and was denied certificate of appealability, rendering his status of in forma pauperis moot, on March 6, 2019. Case no. 18-2355, Tong Lor v. Shane Jackson

4. Petitioner still remains incarcerated and only has a prison job, and is unable to pay the filing fees for Writ of Certiorari. He is providing an affidavit from the prison business office showing his account activity for the past six months, establishing his financial status of indigence. See (Certificate of Prisoner Institutional/Trust Fund Account Activity Affidavit). He is declaring that he has no stocks, bond, or bank accounts, and is unable to pay the required filing costs and fees to file writ of certiorari.

WHEREFORE, Petitioner Tong Lor is requesting the Court to grant him in forma pauperis status, under 28 U.S.C. § 1915(a). He is an American citizen and meets the requirement according to Denton v. Hernandez, 504 U.S. 25, at 31 (1992) ("In enacting the federal in forma pauperis statute, Congress 'intended to guarantee that no citizen shall be denied an opportunity to commence, prosecute, or defend an action, civil or criminal, in any court of the United States, solely because of poverty makes it impossible to pay or secure the costs' of litigation.").

AFFIDAVIT IN SUPPORT OF PETITIONER'S CLAIM FOR INDIGENT STATUS




