My Pro Se Petition For A Writ of Certiorari was filed in this case on July 23rd 2019 and subsequently placed on the docket on August 12th 2019.

Officials in this ^{↙ Maricopa County Sheriff's office} Lower Buckeye Jail will not make any photocopies of documents for the pretrial detainees, so we must get photocopies from an outside source, which is a process that can take several days or even weeks at a time (Please see supporting documents attached as Exhibit A / 14 pages).

Inmate Legal Services (ILS) is very much adversarial with the pretrial detainees in this jail, they are dishonest, they tamper with our court filings, and they are constantly making up excuses to deprive the detainees of case law or other forms of legal assistance. ^{↙ See EXHIBIT A} ILS will tamper with our court filings by removing pages from our pleadings or our attachments, waiting several days to file our pleadings with the Clerk's office so they will be filed late, sending our pleadings over to The Maricopa County Attorney's office so they can get a preview of our documents, ^{↙ especially in criminal cases} before ILS files our documents with the Clerk of the Court, or by repeatedly stapling a blank library book order form to the back of a Pro Se detainee's court filings, in an attempt to make it appear to the Court that the Pro Se detainee is not competent. Often, a Pro Se detainee may not even catch these manipulations until weeks or months later.

Officials in this Maricopa County Jail (Lower Buckeye Jail) ②

have also been opening my mail (clearly marked "Legal Mail"), and making photocopies of my letters and other written communications between me and my attorneys and other members of my legal defense team, sending those confidential communications (that are protected under the Attorney-Client privilege) over to The Maricopa County Attorney's Office, who is then gate stamping my protected legal mail and then putting it into discovery in my criminal case. MCSO officials in this jail have also tampered with my U.S. mail, by making sure that it never reached its destination.

- A one page letter from Phoenix Risk Management Division to Josiah English III, dated February 12th 2019, regarding a Notice of Claim from December of 2018 in which Josiah English III notified the City of Phoenix about this Civil Rights case (that was pending in The U.S. 9th Circuit Court of Appeals at that time), and police misconduct committed by Phoenix Detectives Tyler J. Kipper, Joseph Newbern, Howard Pacifico, and other Phoenix Detectives involved in Josiah English III's criminal case. That letter states:

"We are currently investigating the facts of this incident. If you have any additional information, documentation, photographs, etc. please contact or send this information to me, so that I may include it in the evaluation.
