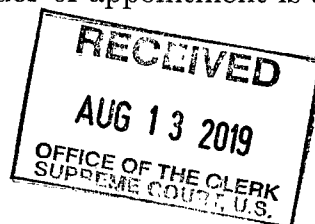

MOTION FOR LEAVE TO PROCEED IN FORMA
PAUPERIS

Comes now Plaintiff/Appellant, Monte Whitehead, pro se and requests this honorable court allow him to proceed on appeal without prepayment of fees. This motion is pursuant to 10th Cir. R. 24 (a)(1), and Mr. Whitehead has entitlement to redress. Plaintiff states the following in support of this motion.

1. Mr. Whitehead is an inmate incarcerated in the New Mexico Department of Corrections and has been incarcerated since January 13, 2006.
2. Plaintiff has already been determined indigent in the present case. See document 73.
3. Plaintiff has included with this motion Form 4 (Affidavit to Accompany Motion for Leave to Appeal in Forma Pauperis).

4. Mr. Whitehead contends that this honorable courts decisions are in error of clearly established law, and he appeals the decisions to prevent manifest injustice. He requests that the Tenth Cir. Court of Appeals address whether the district court erred in determining that:

- (a) Plaintiff/Appellant failed to raise any claims that could amount to violations of his United States Constitutional rights;
- (b) the prison, state, and their named defendants did not violate Plaintiff's First Amendment rights when they denied him Internet and newspaper articles which thwarted his attempts to write an article about private prisons and start a political activist group of people on the outside (not incarcerated). This very issue of First Amendment violations is currently under review by the New Mexico Supreme Court in *Monte Whitehead v. New Mexico Department of Corrections, O.C.P. F. and James Fraunher, Warden*, S-1-SC-3675;
- (c) the use of approved vendors for information and books and the banning of hardbound books from book clubs, publishers and vendors does not violate Plaintiff's First Amendment rights. These issues are also under review in the

above named case;

(d) Plaintiff's claim of First Amendment violations failed because he did not state the prison had no clear penological objective reason for the rejection in his arguments over denial of literature. Plaintiff believes he did make such an argument, but if he did not, he is not required to make such a statement in his complaint or Memorandum;

(e) the prison and other named defendants did not violate Plaintiff's Eighth Amendment right by deliberate indifference when Plaintiff had a documented serious medical condition and prison staff denied him access to see the doctor for several weeks after he had a medical crisis and the defendants tried to coerce Plaintiff into taking a medication he believed precipitated the medical crisis;

(f) the state, prison, and Keefe Commissary Network (KCN) does not violate Plaintiff's and other inmates Fourteenth Amendment rights when they only charge inmates (sex offenders - a politically undesirable group) detained at Otero County Prison Facility sales tax on commissary and not charge inmates in all other facilities in the state sales tax on commissary. All prisons that hold state prisoners are under obligation to the state to provide commissary through (KCN)

of which the state receives thirty (30) percent of all sales. Furthermore, the commissary for the prisoners in question comes from an out of state vendor and location. Therefore, this tax on sex offenders at this prison also violates the commerce clause. This is not a question about a right to commissary but of the state's, prison's, and KCN's unequal treatment of sex offenders;

(g) strip searches before visits do not violate Plaintiff's limited Fourth Amendment rights. At no time has the state or prison expressed or shown reasonable suspicion that Plaintiff or other inmates try to sneak contraband out of prison. Neither have they referred to cases in support of strip searches before visits or shown where an inmate was caught sneaking contraband out of prison. Plaintiff makes no other claim concerning Fourth Amendment rights;

(h) state officials are not liable to suite under § 1983 concluding that Plaintiff only named them in the suit in their official capacity when Plaintiff clearly states he is suing certain state officials in their individual capacity in the complaint

(i) Not allowing Plaintiff to amend the complaint when

he made a motion to do so several months before the court handed down its final judgment. Defendants argued against the motion to amend because Plaintiff did not follow proper procedure, since he failed to attach the proposed amendment. The court did not respond to the motion until its final judgment. Petitioner should have been allowed to amend the complaint and correct deficits.

(3) This case does not present a novel question of law concerning the PRLA's requirement of the grievance procedure before being allowed to pursue litigation while in prison. Because the grievance procedure is now a bar to access of the courts and redress of grievances that no other Americans have to go through, can prisons be held liable when an inmate can show prison officials use and abuse the grievance exhaustion procedure to thwart and frustrate inmates attempts to correct or handle constitutional violations at the prison level and use the grievance process to cause inmates to give up on pursuing remedies with the courts?

Wherefore, Plaintiff/Appellant asks this honorable court allow him leave to proceed in forma pauperis on his appeal to the Tenth Circuit Court of Appeals.

AND TO MAKE PAYMENTS OR SHOW CAUSE

This matter is before the Court on the Motion for Leave to Proceed in Forma Pauperis on appeal filed by Plaintiff, Monte Whitehead, on February 12, 2018 (Doc. 100). Pursuant to § 1915(b)(1), Plaintiff is required to make installment payments until the full amount of the filing fee on appeal is paid. Based on analysis under § 1915(b)(1) of Plaintiff's inmate account statement (Doc. 100 at 13-16), the Court finds that Plaintiff owes an initial partial payment of \$23.15.

IT IS THEREFORE ORDERED that the Motion for Leave to Proceed in Forma Pauperis on appeal filed by Plaintiff, Monte Whitehead, on February 12, 2018 (Doc. 100) is GRANTED;

IT IS FURTHER ORDERED that, within thirty (30) days of entry of this Order, Plaintiff send to the Clerk an initial partial payment of \$23.15 or show cause why payment should be excused;

IT IS FURTHER ORDERED that the Clerk is directed to provide Plaintiff with two copies of this Order, and that Plaintiff make the necessary arrangements to attach one copy of this Order to the check in the \$23.15 amount of the initial partial payment;

IT IS FINALLY ORDERED that, after payment of the \$23.15 initial partial fee, Plaintiff make monthly payments of twenty per cent (20%) of the preceding month's income credited to his account or show cause why the designated payments should be excused.
