Reargue & Renew for Leave

*In Forma Pauperis*

The Petitioners' ask for Leave to Renew and Reargue the denial of leave to proceed *In Forma Pauperis* in the above referenced matter.

1. The Petitioners have been granted *In Forma Pauperis* status in New York Courts and have no assets. The Petitioners' expenses to house and feed themselves exceed their indigent level income, as documented in the attached affidavits and New York State Court rulings, Exhibit "1".


2. The U.S. Supreme Court denied leave to proceed *In Forma Pauperis* on October 21, 2019 ( Exhibit "2") based upon a Detrimental ERROR by the Clerk's Office that had Pro Se Petitioner, Regan Lally, incorrectly listed as "Attorney for Petitioner" (Exhibit "3"), which would require re-filing pursuant to Rule 33.1 and payment of the \$300.00 filing fee. This error was just discovered.

3. All of the Defendants were served the Petitioners Writ of Certiorari and Appendix in May 2019 and have filed waivers, not appeared, and one has filed a Brief in Opposition, two months ago, pursuant to this Honorable Court's briefing schedule.

4. All of the Defendants were served the Petitioners' Motion to Proceed *In Forma Pauperis*. None of the fifteen Defendant's interposed any opposition to the U.S. Supreme Court granting *In Forma Pauperis* status to the Pro Se Petitioners.

WHEREFORE: Based upon; (A) the detrimental error in the above referenced matter in listing one of the Pro Se Petitioners as "Attorney for Petitioners" (Exhibit "3), (B) the New York State Courts granting Petitioners *In Forma Pauperis* status, (C) the Affidavits that provide proof that Petitioners' expenses exceed their income, (D) no opposition presented in response to Petitioners' Motion for leave for *In Forma Pauperis* status, (E) the Defendants' responses to the Writ of Certiorari already received in the past due briefing schedule, and (F) the extraordinary and impossible expense that it would cost all parties, Petitioners respectfully request that this Honorable Court grant leave to Petitioners to proceed *In Forma Pauperis*.
